- On page 2, underneath the Job Placement Rates table there is a mandatory statement "You may obtain...," you need to explain how a student may get this information (many schools just say ask a representative).
- On page 3 you have the statement "IF the majority of graduates...," this does not pertain to your program so you may delete this.
- On page 4, you used the non continuous table. The exams for beauty programs are continuously offered throughout the year. You need to use the other exam table.

- On page 5, underneath the Salary and Wage information table there is a mandatory statement "A list of sources...", you need to explain how a student may get this information (many schools just say ask a representative).
- On page 5, please delete the cost of the program in 2016 only show 2017 cost.
- All SPFS are missing the cancellation policy. This statement must be on a separate document but be included in each SPFS packet.

Also, your website is missing the current SPFS and Catalog.
